To ensure proper monitoring and control of MARSIK project activities a two level project control method is proposed. Routine project management and co-ordination of activities will be the responsibility of SM. To support this a task definition and reporting system as shown in the attached sample will be produced. This will provide the basis for monthly progress reporting on each task. Responsible officers will be asked to write in monthly progress on the forms, which will be collected, reports input to LIBRETTO and copies made and distributed to all project participants. Monthly meetings will be held to review project progress, proposed participants to include SM, SMT, SMT2, SMO, AF, AP, CH, CHR, STE.

2. In view of the importance of the project, and the substantial involvement of several DSD branches it is suggested that a Directorate steering committee would also be beneficial in ensuring effective co-ordination and progression of the project. This could take the form of a monthly meeting chaired by ADD, with ADS, ADC, ADA and SM participating. A possible alternative would be for SM to make a report to the Director's meeting, either monthly, or as required.
